

Sustainable Development Policy on Donations and Financing (Sustainability and Integrity) of KSMA named after I.K. Akhunbaev

1. General Provisions

1.1. This Policy defines the principles and procedure for attracting, using and reporting on donations and financing in the Kyrgyz State Medical Academy named after I.K. Akhunbaev (hereinafter referred to as KSMA), based on the principles of sustainable development and integrity.

1.2. The Policy has been developed in accordance with the legislation of the Kyrgyz Republic, the Charter of KSMA, as well as international standards in the field of sustainable development and ethics.

1.3. The purpose of this Policy is to ensure transparency, accountability and efficiency of using the funds raised to achieve the goals of sustainable development of KSMA, including improving the quality of education, developing science, modernizing infrastructure and supporting socially significant projects.

2. Principles of Sustainability and Integrity

2.1. Transparency: KSMA provides open access to information on funds raised and used, including sources of funding, purposes of expenditure and results of project implementation.

2.2. Accountability: KSMA is responsible to donors, beneficiaries and society for the effective and targeted use of donations and funding.

2.3. Ethics: KSMA adheres to high ethical standards in its activities, excluding any forms of corruption, fraud and conflict of interest.

2.4. Sustainability: KSMA strives to attract long-term and sustainable sources of funding that contribute to the stable development of the Academy and the implementation of strategic goals.

2.5. Targeted use: Donations and funding are used exclusively for the purposes defined by donors and consistent with the mission and strategic priorities of KSMA.

2.6. Social responsibility: KSMA takes into account social and environmental aspects when implementing projects financed by donations and other sources.

3. Sources of Funding

3.1. KSMA may attract funding from the following sources:

- Donations from individuals and legal entities (residents and non-residents).
- Grants from government and international organizations.
- Targeted funding from foundations and other institutional donors.
- Income from the provision of paid educational and other services.

4. The procedure for attracting and using funds

4.1. Donations and funding are attracted on the basis of public contracts, agreements or grant agreements, which clearly define the goals, conditions and procedure for using funds.

4.2. KSMA creates a special fund or target account to record donations and targeted funding.

4.3. The funds are used in accordance with the approved budget and project implementation plan.

4.4. KSMA keeps strict records of the receipt and expenditure of funds and provides regular reports to donors and the public.

5. Reporting and control

5.1. KSMA publishes an annual report on the funds raised and used on its official website.

5.2. The financial statements of KSMA are subject to annual audit by an independent audit company.

5.3. A commission for monitoring the use of donations and funding is created at KSMA, which may include representatives of the public and donors.

6. Final Provisions

6.1. This Policy is approved by the decision of the Academic Council of KSMA and comes into force from the moment of approval.

6.2. Amendments and additions to this Policy are made by the decision of the Academic Council of KSMA.

6.3. KSMA ensures that all employees and stakeholders are familiar with this Policy.

Additional recommendations:

- Develop detailed procedures for each type of funding (donations, grants, targeted funding).
- Create a section on the KSMA website dedicated to reporting on donations and funding.
- Actively interact with the public and the media to increase the transparency and accountability of KSMA activities.
- Implement a system of internal control over the use of funds.
- Organize employee training on ethics and anti-corruption issues.

This policy is a framework that needs to be adapted to the specific conditions and objectives of KSMA. It is important to consult with lawyers and experts in the field of financial management and sustainable development to ensure full compliance with legislation and best practices.
